the map with dispatch.

Operations

Safety

- Jim highlighted some of the statistics from the NFPA firefighter deaths report that he had emailed out to all members. Of note, overexertion and stress accounted for just over half the deaths in 2022 (cardiac events). He urged members to review the report.
- Jim also talked about avoiding the soft shoulder of the road and reminded members that if they're driving apparatus and drop tires off the edge of the road, don't turn the wheel to correct/get back on the road because you'll roll over. If you're stable where you are, stop and we'll figure out how to get it unstuck.

As the Membership Desires

- Craig reported that the Hidden Park staging area has been approved by the Road & Rec Board.
- Doug announced that will no longer respond to medical calls in Red Feather or Crystal Lakes. He will respond as CL2 to Crystal and Red Feather calls as a firefighter.
- Mark was asked to leave while a vote was taken on whether to make him a full member. Vote result: yes.
