

INCIDENT REPORTS FOR 2021

January 3, evening -- Incident #1 -- medical call in Filing 4 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

February 2, evening -- Incident #2 -- structure fire in Red Feather Lakes -- CLVFD firefighters responded auto-aid (meaning the type of call resulted in our being paged automatically to respond) to assist Red Feather Lakes VFD firefighters with a structure fire in Red Feather Lakes. The kitchen fire had been extinguished by the resident before responders arrived. Firefighters confirmed the fire was out and used a thermal imaging camera to check for any fire spread inside the walls while medical responders cared for the resident, who was burned in the incident.

February 12, afternoon -- Incident #3 -- fire alarm in Red Feather Lakes -- CLVFD firefighters responded auto-aid (meaning the type of call resulted in our being paged automatically to respond) to assist Red Feather Lakes VFD with the report of a fire alarm going off at the Red Feather Lakes Elementary School. RFLVFD responders determined that the alarm was caused by a malfunction before CLVFD arrived on scene and stood all responders down.

March 6, morning -- Incident #4 -- fire call in Red Feather Lakes -- CLVFD firefighters responded auto-aid (meaning the type of call resulted in our being paged automatically to respond) to assist Red Feather Lakes VFD firefighters with a report of a brush fire threatening a structure. Red Feather responders quickly determined that the fire was in a firepit, which the homeowner was monitoring, and all responders stood down.

March 26, evening -- Incident #5 -- medical call in Filing 9 -- CLVFD emergency medical responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

April 2, pre-dawn -- Incident #6 -- medical call in Filing 7 -- CLVFD emergency medical responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

April 14, afternoon -- Incident #7 -- medical call in Filing 3 -- CLVFD emergency medical responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

April 19, evening -- Incident #8 -- MVA/mutual aid to Red Feather -- CLVFD responders turned out to assist Red Feather Lakes VFD in controlling traffic around a motor vehicle accident near the Red Feather school.

April 26, morning -- Incident #9 -- fire/mutual aid to Red Feather -- CLVFD firefighters turned out to assist Red Feather Lakes VFD with a fire that had started in a log pile at the Slash Depot. Special Duty Responders set up traffic control around the scene to ensure safe passage of vehicles past the incident.

May 7, morning -- Incident #10 -- gas leak/mutual aid to Red Feather -- CLVFD firefighters turned out to assist Red Feather Lakes VFD with a report of a possible gas leak at Chapel in the Pines. With the use of a multigas meter, firefighters were able to determine that there was no detectable leak.

May 10, evening -- Incident #11 -- rescue/mutual aid to Red Feather -- CLVFD firefighters turned out to assist Red Feather Lakes VFD with a report of a traveler stuck near Lost Lake and walking in the snow/cold.

May 17, afternoon -- Incident #12 -- slash burn in Filing 1 -- CLVFD firefighters responded to a report of a property owner burning slash in an unsafe fire pit. Responders made contact with the property owner, who had already extinguished the fire, and discussed safe burning requirements before standing down.

May 24, afternoon -- Incident #13 -- hazmat/mutual aid to Red Feather -- CLVFD firefighters turned out to assist Red Feather Lakes VFD with a report of a vehicle leaking fuel on Deadman Road.

May 29, afternoon -- Incident #14 -- MVA/mutual aid to Red Feather -- CLVFD firefighters turned out to assist Red Feather Lakes VFD with a vehicle crash that resulted in serious injury.

June 6, evening -- Incident #15 -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for the AirLink helicopter and Special Duty Responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set

up traffic control around the scene and the landing zone so responders could arrive and leave safely.

June 8, morning -- Incident #16 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

June 8, noon -- Incident #17 -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

June 11, morning -- Incident #18 -- fire alarm/mutual aid to Red Feather -- CLVFD firefighters turned out to assist Red Feather Lakes VFD with a report of fire alarms going off at a property under construction. No fire was found and all responders stood down.

June 11, evening -- Incident #19 -- overturned kayak in Crystal Lake -- CLVFD firefighters turned out in response to a report of a kayak seen floating upside down in the lake with no sign of anyone nearby. Responders searched the lakeshore and were preparing to launch a boat with cold water rescue equipment when friends of the overturned kayakers made it back to the lake after taking the victim to a nearby house to get warm and dry and reported that he was safe. CLVFD emergency responders went to the house to check on the victim and ensure he did not have hypothermia. Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene and the house so responders could arrive and leave safely.

June 12, afternoon -- Incident #20 -- medical call at fire station -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders staged to provide lead-in for the Red Feather Lakes ambulance.

June 14, evening -- Incident #21 -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders provided lead-in for the Red Feather Lakes ambulance and set up traffic control around the scene so responders could arrive and leave safely.

June 14, evening -- Incident #22 -- MVA on 73C -- CLVFD firefighters responded to a report of a motor vehicle accident on 73C on the NE end of Crystal while Special Duty Responders provided to handle traffic control. This incident was quickly determined to be a false alarm from the vehicle's safety system and all responders stood down.

June 16, morning -- Incident #23 -- MVA on North Ottawa -- CLVFD emergency responders provided patient assessment and care while firefighters verified that the vehicle was not leaking fluids and Special Duty Responders staged to provide lead-in for the Red Feather Lakes ambulance (which was ultimately stood down before arriving in Crystal Lakes) and set up traffic control around the scene so responders could work safely.

June 17, evening -- Incident #24 -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders staged to provide lead-in for the Red Feather Lakes ambulance, which was ultimately stood down before entering Crystal Lakes.

June 17, night -- Incident #25 -- medical/mutual aid to Red Feather -- CLVFD emergency responders turned out to assist Red Feather Lakes VFD with a medical call at the Potbelly Restaurant.

June 21, night -- Incident #26 -- medical/mutual aid to Red Feather -- CLVFD emergency responders turned out to assist Red Feather Lakes VFD with a medical call the intersection of 67J and Forest Road 311.

June 22, evening -- Incident #27 (Dispatch accidentally skipped #26) -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders provided traffic control around the scene so the Red Feather ambulance could arrive and leave safely.

June 23, noon -- Incident #28 -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for the AirLink helicopter and Special Duty Responders provided lead-in for the Red Feather Lakes and UC Health ambulances and set up traffic control around the scene and the landing zone so responders could arrive and leave safely.

June 26, morning -- Incident #29 -- smoke report in Filing 15 -- CLVFD firefighters responded to search for the source of a white column of smoke that was spotted in the 15th filing while Special Duty Responders stood by to lead engines from outside agencies to the scene if additional help was needed. The smoke was tracked to an approved firepit, which was putting up a lot of smoke due to the wet wood being burned.

June 26, afternoon -- Incident #30 -- medical call in Filing 12 -- CLVFD emergency responders provided patient assessment and care while Special Duty

Responders stood by to lead in the Red Feather ambulance, which was stood down before it reached Crystal Lakes.

June 29, evening -- Incident #31 -- medical call in Filing 13 -- CLVFD emergency responders provided patient assessment and care while firefighters stood by to set up a landing zone for Lifeline (ultimately not required) and Special Duty Responders led in the Red Feather ambulance and set up traffic control around the scene so responders could arrive and leave safely.

July 1, afternoon -- Incident #32 -- fire call in Filing 11 -- CLVFD firefighters responded to a report of smoke and flames near a trailer. They found an unattended campfire and extinguished it before it could spread to nearby structures. We've received rain lately, but we did not and do not receive enough rain to make leaving your campfire without making sure it is FULLY extinguished anything but dangerous to the whole community.

July 1, evening -- Incident #33 -- medical call in Filing 14 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders led in the Red Feather ambulance and set up traffic control around the scene so responders could arrive and leave safely.

July 3, morning -- Incident #34 -- medical/mutual aid to Red Feather -- CLVFD emergency responders turned out to assist Red Feather Lakes VFD with a medical call.

July 6, evening -- Incident #35 -- medical call in Filing 15 -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for Lifeline (ultimately not required) and Special Duty Responders led in the Red Feather ambulance and set up traffic control around the scene so responders could arrive and leave safely.

July 10, night -- Incident #36 -- medical call at Creedmore Lakes campground -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for Lifeline (ultimately not required) and Special Duty Responders led in the Red Feather Lakes and UC Health ambulances and set up traffic control around the scene so responders could arrive and leave safely.

July 15, evening -- Incident #37 -- medical call at Creedmore Lakes campground -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for Lifeline and Special Duty Responders led in the Red Feather Lakes and UC Health ambulances and set up traffic control around the scene so responders could arrive and leave safely.

July 17, evening -- Incident #38 -- medical call in Filing 9 -- CLVFD emergency responders provided patient assessment and care while firefighters set up a landing zone for Lifeline at Red Feather Station and Special Duty Responders led in the Red Feather Lakes and UC Health ambulances and set up traffic control at Yuki and 73C so the ambulances could get safely back out on the road.

July 23, morning -- Incident #39 -- motor vehicle accident in Filing 9 -- CLVFD firefighters responded to a report of a powerline down on Nicola Way due to a run-in with a vehicle. They verified that the crew in the truck that hit the line were unharmed, that the line was de-energized, and worked with Special Duty Responders to handle traffic control and prevent anyone from driving down the road while the lines were down or while PVREA was working on them.

August 9, evening -- Incident #40 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders led in the Red Feather Lakes ambulance and set up traffic control so it could get safely back out on the road.

August 21, evening -- Incident #41 -- mutual aid to RFLVFD -- CLVFD responders stood by at our station until it was determined that the Red Feather Lakes VFD responders to a medical call with rescue at Lost Lake did not need additional assistance.

August 21, evening -- Incident #42 -- motor vehicle accident in Filing 8 -- CLVFD responded to an ATV accident on South Ottawa Way. Emergency responders provided patient assessment and care while firefighters set up a landing zone for Lifeline and Special Duty Responders led in the Red Feather Lakes and UC Health ambulances and set up traffic control around the landing zone for the safety of firefighters and the helicopter crew and around the scene so responders could work safely.

August 22, evening -- Incident #43 -- medical call at Beaver Meadows -- CLVFD emergency responders provided patient assessment and care while firefighters stood by in case a landing zone was needed for a helicopter and Special Duty Responders staged to lead in the Red Feather Lakes and UC Health ambulances. All medical resources aside from our own were stood down before reaching the scene.

September 2, evening -- Incident #44 -- mutual aid to RFLVFD -- CLVFD emergency responders rolled out to assist Red Feather Lakes VFD with a medical call in the general area of Lost Lake.

September 3, afternoon -- Incident #45 -- medical call in Filing 5 -- CLVFD emergency responders provided patient assessment and care while firefighters stood by in case a landing zone was needed for a helicopter and Special Duty Responders led in the Red Feather Lakes ambulance.

September 5, evening -- Incident #46 -- fire call in Filing 14 -- CLVFD firefighters responded to a report of a dangerous campfire in Filing 14, with Special Duty Responders staging along 73C to provide lead-in and traffic control if necessary. Firefighters determined that the campfire in question had already been put out, had a conversation with the property owners about safe burning, and stood down.

September 9, morning -- Incident #47 -- mutual aid to RFLVFD -- CLVFD firefighters responded to our station to prepare to assist Red Feather Lakes VFD with a possible fire at Red Feather Elementary School. This was determined to be a false alarm and all responders stood down.

September 25, morning -- Incident #48 -- mutual aid to RFLVFD -- CLVFD firefighters responded to assist Red Feather in finding and extinguishing an unattended campfire on Deadman Road.

October 2, evening -- Incident #49 -- smoke report west of Crystal Lakes -- CLVFD firefighters responded to a report of smoke sighted to the southwest of the Pearl Creek area. After some searching, responders were able to determine the smoke was coming from a campfire in the national forest and verified there were campers monitoring the fire and burning safely.

October 3, morning -- Incident #50 -- fire call in Filing 9 -- CLVFD firefighters responded to a report of a fire burning to the east of North County Road 73C, which the caller had been unable to confirm was a monitored campfire. Responders determined that the fire was, in fact, a campfire and the property owner was present and burning safely.

October 12, evening -- Incident #51 -- medical call in Filing 14 -- CLVFD emergency responders provided patient assessment and care while firefighters stood by in case a landing zone was needed for a helicopter and Special Duty Responders led in the Red Feather Lakes ambulance.

October 16, evening -- Incident #52 -- smoke report in Filing 12 -- CLVFD firefighters responded to a report of smoke sighted on the south side of Panhandle Reservoir. After some searching, responders were able to determine the smoke was coming from the chimney of a cabin on South Ottawa.

October 17, morning -- Incident #53 -- fire call in Filing 11 -- CLVFD firefighters responded to a report of a possibly slash burn in the 11th Filing. Responders determined that the fire was a campfire and the property owner was present and burning safely.

October 25, morning -- Incident #54 -- medical call in Filing 6 -- CLVFD personnel responded to a report of a medical alert button having been pressed. They were unable to find anyone at the residence, but were able to get in touch with the owner and determine that the button had been pressed accidentally.

November 11, pre-dawn -- Incident #55 -- mutual aid to RFLVFD -- CLVFD firefighters responded to assist Red Feather, who were investigating a residential fire alarm, in case a fire was discovered. No fire was found and all responders stood down.

November 19, afternoon -- Incident #56 -- MVA on Catawba Rd -- CLVFD firefighters responded to a vehicle that had skidded over an embankment. There were no injuries and responders kept traffic away from the scene until the car was pulled to safety.

November 30, evening -- Incident #57 -- fire report in Filing 9 -- CLVFD firefighters responded to a report of flames sighted in the 9th filing. After some searching, responders determined that what looked like flames was, in fact, a bright porch light that appeared to be flickering due to the trees dancing in the wind in front of it. Reminder: we'd much rather you call us out if you think you see something than hesitate because you're not sure. In conditions like on this night, the high wind could spread a fire extremely fast.

December 1, afternoon -- Incident #58 -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while firefighters helped establish a landing zone for the helicopter in Red Feather and Special Duty Responders led in the Red Feather Lakes ambulance.

December 3, afternoon -- Incident #59 -- medical call in Filing 7 -- CLVFD emergency responders provided patient assessment and care while firefighters established a landing zone for the helicopter and Special Duty Responders led in the Red Feather Lakes and UC Health ambulances.

December 11, evening -- Incident #60 -- CO alarm in Filing 14 -- CLVFD firefighters responded to a report of a carbon monoxide detector going off. Using our gas meter, we were able to determine that the alarm was in error and there was no carbon monoxide.

December 12, afternoon -- Incident #61 -- mutual aid to RFLVFD -- CLVFD firefighters responded to assist Red Feather in searching for a fire reported smoldering along the Mount Margaret trail. Responders determined that the smoldering logs were part of a recent forest service controlled burn and were within the burn area, where the fire could not spread and it was preferred for things to burn themselves out naturally, and stood down.

December 19, morning -- Incident #63 (62 was issued in error by dispatch) -- medical call in Filing 13 -- CLVFD emergency responders provided patient assessment and care while Special Duty Responders set up traffic control around the scene and led in the Red Feather Lakes and UC Health ambulances.

December 19, evening -- Incident #64 -- powerlines down in Elkridge -- CLVFD firefighters responded to maintain a watch on downed powerlines and keep traffic from passing through the area until PVREA could arrive to repair them.

December 28, afternoon -- Incident #65 -- medical call in Filing 8 -- CLVFD emergency responders provided patient assessment and care while firefighters plowed a route to the scene through drifts and Special Duty Responders led in the Red Feather Lakes and UC Health ambulances.
