Robin shared the updated contract. Pinnacle removed the requested compliance item regarding 1099s from the contract. The Board will take some time to further investigate current regulations and revisit the District's need for this service later in the year. The Board was pleased with the changes and agreed to have President Lauric sign the contract on behalf of the District.
